93	(c) Utah supports the timely and appropriate negotiated settlement of federally reserved
94	water right claims for both Native American trust lands and other existing federal reservations,
95	and opposes any future designation of public lands that does not quantify any associated
96	federally reserved water rights.
97	(2) State agencies are encouraged to conduct agency activities consistent with
98	Subsection (1) and implement policies established by the Legislature that promote the near-
99	and long-term stewardship of water quality and water resources.
100	(3) This section does not create a cause of action against the state's or a state agency's
101	action that is inconsistent with Subsection (1) and does not waive governmental immunity
102	under Title 63G, Chapter 7, Governmental Immunity Act of Utah.
103	(4) The Natural Resources, Agriculture, and Environment Interim Committee shall
104	review the state water policy annually and recommend priority balancing and any other changes
105	to the Legislature.
